or administration that would come from setting up a personal foundation. Individuals also have full decision-making authority over how their funds are disbursed.



Highlights of 2013

January 2013 - Donation to MRI

The Foundation made a gift of \$5,000 to the Pembroke Regional Hospital MRI Fund. The Foundation was created to provide financial support to local charities, groups, and organizations. In a release, Matt Bradley, Chair of the Community Foundation, highlighted the importance of having such a machine in the Ottawa Valley and was grateful they were able to support the campaign.



March 2013 - Colby's Crusade

The Foundation is the host organization for fundraising for Colby's Crusade. The fund is for Colby Audette who has been diagnosed with Duchenne Muscular Dystrophy, a disease for which there is no cure. Colby will require equipment to assist his daily living, which is why the Fund was established. Funds were raised with a walk-a-thon that earned \$11,000 in 2013.

May 2013 - Krista Johnson Memorial Fund

The Foundation is the host organization for the Krista Johnson Memorial Fund. The fund is established to honour Pembroke native, Krista Johnson who died as a result of a cycling accident in 2012. Krista had a strong community spirit and promoted healthy living. The Krista Johnson Memorial

Run for Change attracted 800 runners who raised an estimated \$15,000. In 2013, the major beneficiaries of the funds raised were The Grind and the exercise equipment at Riverside Park in Pembroke.




July 2013 - National Campaign





Accounting Notes

The Foundation is a registered charity designated as a public foundation. It benefits the community by providing funds to local charitable organizations that are also registered charities under the Income Tax Act as well as improving the efficiency and effectiveness of other registered charities through the holding of conferences, by identifying and meeting community needs and the provision of administrative services.

The Foundation follows the restricted fund method of accounting for contributions.



Making A Donation

Deferred gifts will help the Foundation at a future date, while also serving to benefit the donor's estate.

Funds may be invested as an endowment fund to generate income, in perpetuity, for charitable causes. They may also be spent promptly as per the donor's wishes.
